## SPECIAL EVENTS

There have been 2 novice jamborees (Stony Plain and Drayton Valley) to date with another 2 scheduled for Edmonton (Nov 29) and Wetaskiwin (Dec 12).

## EMHA AND MINOR COMMITTEE

Hello everyone I hope you're having a great hockey season so far. The Edmonton AA hockey program is off to another good start. There have been very few complaints from the EMHA this season so keep up the good work. Minor Committee has met several times to review, add and delete officials from our lists.

We have seen plenty of movement once again with officials moving up the lists and with new officials as well as officials coming from out of town being added to our program.

I would like to remind all officials working the AA program that you must dress appropriately (collared shirt and dress pants and no ball caps). You must also show up a minimum of 30 minutes prior to game time. If you take an assignment it is yours to keep. If you have to cancel a minimum of 48 hrs is required with a good reason for canceling. So before you take an assignment check your schedule to make sure you're available. No shows and late cancellations continue to be a problem and are unacceptable. If there is a no show in one of your games, one official will call Herman Costa (Minor Committee chairman) or their assignor within 48 Hrs. All officials who do not abide by these rules will be turned over to the discipline committee.

Also with Christmas coming we all know it is tournament time. The Bantam AA and AAA tournament in Callingwood arena. Bill Kurucz Midget AA and Mid 15 AAA minor tournament at the CAC arena. There will also be many Federation tournaments in the city of Edmonton this holiday season. ## HOCKEY CANADA BULLETIN—H1N1

Ladies and Gentlemen:

Hockey Canada would like to emphasize that the information distributed in bulletin I10-03 related to the H1N1 virus has not changed with respect to recommendations around its prevention.

Saying this, we have had numerous enquiries with respect to **shaking hands with** team officials at the beginning of the game as part of the FAIR PLAY INITIATIVE.

Although the spread of germs can be done in many forms, and simply not shaking hands doesn't in itself eliminate the spread, it is entirely up to your Branch or Associations as to what you dictate around shaking hands with team officials. If your organization decides to identify other options to replace handshaking we would recommend asking officials to verbally greet team officials at the bench. Keep in mind we still stress that promoting the preventative guidelines distributed is as important.

## FEDERATION NOTES

### A BIG CONCERN

There is a large surplus of officials in the Edmonton BB program this season. The problem is greatest for entry level officials. There is not enough hockey to offer these officials more than 2 or 3 games per month. Considering the premium this shortage of games places on assignments, all officials must insure that assignments are kept. There must not be any no shows. If you cannot do the game that you committed to do, contact your assignor by telephone in order that someone else can have an opportunity.

### GIVING BACK

The Edmonton Minor Hockey Association's Quikcard Minor Hockey Week Tournament is January 15 to 24, 2010. This is a very large tournament with a great deal of exciting hockey. All officials donate their officiating time. Please participate when asked or better yet call a Federation assignor and volunteer. Get involved. Referee for free!

### RAMP

The computer assigning system works most efficiently if you the official participate. This means FREQUENTLY visiting your mailbox for potential assignment. REGULARLY entering and updating your dark times. PROMPTLY accepting or declining potential assignments. Failure to follow these guidelines will result in you receiving fewer assignments.

### ATOM 4 ON 4

Hockey Alberta and the Edmonton Minor Hockey Association held a 4 on 4 Atom tournament on November 1, 2009 at Coronation Arena. Six officials worked the half ice shinny games. The officials assigned were Cody Mathews, Brendon Gore, Jonathan Kikuchi, Travis Preston, Mark Grundy and Deane Woywitka.

### THE SEASON

League play began on October 7, 2009. Round 1 play concluded on November 27, 2009. Round 2 began play on November 28, 2009 and concludes on January 14, 2010. Round 3 will commence on January 25, 2010. The playoff round will be in March 2010. The Edmonton – Calgary Provincial playoff in Midget Tier 1 and 2, Bantam Tier 1 and 2 and Pee wee Tier 2 will be in Edmonton in March 2010.

### RULE EMPHASIS

The Hockey Canada rule emphasis for 2009 – 2010 is checking to the head. All officials must work to insure that high hit violations are penalized. Review your guidelines for severity of the high hit and your penalty options depending upon the severity of the hit. Continue to enforce the standard of play. If you see a rule violation, assess the appropriate penalty. The severity of the violation, the time of the penalty in the game, the score in the game, and the mood of the referee are considerations which should not become a factor in deciding if a penalty will be assessed. If you see it, call it! Restraining fouls continue to be a priority. For restraining fouls there is a danger zone and there may be consequences as a result of a player entering a danger zone. If consequences occur, the referee must assess a penalty when he sees the consequences of a player having entered the danger zone.

Remember that you never know who is in the stands watching your game; keep working hard and show professionalism.

## CLINIC INFORMATION

By the time the newsletter goes to print, the clinic season will have come to a close.

We started the season with six 1-day classes being held at Grant MacEwan university downtown and by all reports and comments; it was a very good choice to have used this facility. The only drawback that I had heard about was the parking and the lack of signage letting everyone know where the classes were being held. A second date, October 17<sup>th</sup> & 18<sup>th</sup> were also used to get as many of our remaining officials registered. A huge thank you goes out to Fraser Lawrence for his help in pre-registering the officials for those classes.

This year we ran approximately 76 clinics across the zone. By all accounts, our numbers are up from last year which caused us some headaches as we ran out of supplies which is not necessarily a bad thing since next year is a rule change year, but it caused some trouble in trying to make sure our instructors had enough supplies to instruct the final clinics.

We will be holding an instructor meeting on December 14<sup>th</sup> to get feedback from each of the instructors about how they thought the clinics went this year as well as get some feedback from them to find out how we can improve our clinic program in the zone. We will also be talking about the clinic schedule next year as we will start to incorporate more e-learning clinics into our program. I will also be in contact with all the local RIC's so that we can start to plan our clinics for next year, keeping them in the loop and getting any ideas or suggestions from them.

Thank you to Mike Rebus, who took on the lead role in the pilot project for the e-learning this year. Mike ran one e-learning class at the Southeast zone clinic and from all accounts, it was a success. With some help from Mike, Craig Miller ran a 2<sup>nd</sup> e-learning class in Beaumont on Saturday, November 21<sup>st</sup>.

Thank you to Jim Bassingthwaite for his contribution of putting our clinic kits together this year as this is a very tough job to do especially when you are not only instructing, but also officiating, plus holding down a full-time job.

In closing, I think we did a very good job this season with our clinics and I look forward to working with everyone again next year. I would also like to thank everyone for their support and encouragement, especially Kumail and Lance.

## REMINDER:

**If you're a hockey player & you're under suspension from hockey, you're also suspended from officiating until such time you are re-instated**

## MATCH PENALTY ON OFFICIAL

A handful of match penalties on officials have been reported to date. While this is down from previous years it is my opinion that even one of these penalties is "one too many." This is the most severe penalty in the rule book so it is important that you are assessing the proper penalty based upon the infraction.

Do not confuse the match penalty on an official with the match penalty on a player. A match penalty on a player is assessed when there is a deliberate attempt to injure. Whereas a match penalty on official is assessed only under the following four instances:

Spitting - A Match penalty shall be assessed any player or team official who deliberately spits on or at an opponent, official, team official or spectator.

Verbal threat or attempted strike - Any player or team official who threatens or attempts to strike a Referee, Linesman, or any Off-ice Official; before during or after a game shall be assessed a Match penalty.

Pushing or holding - any player or team official, who intentionally touches, holds or pushes a Referee, Linesman, or Off-ice Official; before, during or after a game shall be assessed a Match penalty.

Striking - Any player or team official who deliberately strikes, trips or body checks a Referee, Linesman, or Off-ice Official; before during or after a game shall be assessed a Match Penalty.

\*For all these situations, you must ensure that the intent of the action was directed towards one of the officials and not another player, coach or fan.

If one of the four incidents above should occur then you must follow the procedure laid out by Hockey Alberta. The details of this were provided at your clinic or they can be accessed on the North Zone website at [http://www.northzone.ab.ca/match\\_penalties.htm](http://www.northzone.ab.ca/match_penalties.htm).

There are times where a match penalty on an official can be avoided by remaining calm, identifying yourself accordingly, and staying back from situations that could result in the calling of this penalty. It is important that you read and react to what is happening and either diffuse the situation through communication or move to an area where it is less likely for an incident to occur.

Hopefully I will not have to speak with you in regards to this penalty. Enjoy the remainder of the officiating season and Happy Holidays.

## TREASURER CENTS

Are you missing your last two pay cheques? Are you not getting calls from assignors? Did you borrow this newsletter from a friend because you never get one? Have you moved? Has your phone number changed? Did you tell us? If any of this sounds familiar, we need to hear from you. Don't rely on your information being updated when you take your clinic, depending on our workload and where you take your clinic, it could take until mid January to have your record updated, which in some cases, means you will miss two newsletters and three pay cheques. If you officiate Senior male or female hockey, or "A" hockey in Edmonton, you will receive your game fees by cheque at the monthly general meetings, except November games which are mailed in early December, and February games which are available at the April General meeting. Game fees are calculated using the information received from your assignors, if you feel your pay is incorrect, check with your assignor first. You also need to contact your assignor if your assignment has changed, for example you are assigned to be a linesman in a game, but one of your partners does not show, you need to tell your assignor so your pay can be adjusted.

## REFEREE IN CHIEFS



The first half of the season has come and gone and things seem to be going well in the rural areas of the zone. While some centers seem to be struggling to find officials to cover games there is a great amount of communication amongst assignors and referee in chiefs which is helping to ensure that the games get covered. I must commend all these individuals for their hard work as it would be terribly unfortunate if games were cancelled due to inability to find officials.

We had a great turnout for our September meeting where we discussed everything from clinics to supervisions to recruitment and retention of officials. The next meeting will be after the New Year in January. Details will be forwarded to all referee in chiefs once the date and location has been confirmed.

A few questions that I have received to date that I would like to share are as follows:

Q. If an official has received a suspension as a player, can they still referee?

A. No. Suspended players that are officials are suspended from all hockey. Therefore they cannot play or officiate until their suspension has been served. The suspension is effective from the time of notification. In some cases it may be immediate (if so indicated by the rulebook).

Q. If an official is injured and unable to play hockey, can they still referee?

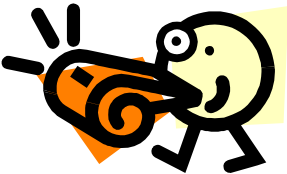
A. Yes, however the official needs to be aware that they could cause further injury to themselves. It may be a good idea to have them discuss this with their doctor. They also need to be aware of the injury and to act accordingly when dealing with players. The greatest drawback to this would be further injury and as such the official needs to accept assignments accordingly.
